

**TOWN OF MAIDSTONE
BYLAW NO. 12/2019**

A BYLAW TO AMEND BYLAW NO. 2018-02

The Council of the Town of Maidstone, in the Province of Saskatchewan, enacts as follows:

That Bylaw No. 02/2018 respecting pet licensing sections 4 and 6 is amended:

1. By striking out in its entirety Sections 4 and 6 and substituting as follows.
 4. **ANIMAL LICENCE**
 - a. A person who acquires and keeps a dog/cat within the Town of Maidstone
 - 1) Must acquire a dog/cat licence for each animal from the Town;
 - 2) For each animal, must provide the information necessary on the “Pet Licence Registration Form” as shown in Schedule “C”;
 - 3) Pay a one-time licence fee of \$25; and
 - 4) Must advise the Town each January of whether the dog/cat still resides at that residence.
 - b. The Town issues a dog/cat tag upon approval and payment of the Animal Licence.
 - c. The dog/cat must wear his tag at all times.
 6. **REPLACEMENT DOG/CAT TAG**
 - a. If a dog/cat’s tag is lost, a replacement tag must be acquired from the Town for the animal at a cost of \$25 per tag.
2. By adding new Schedule “C” Town of Maidstone Pet License Registration Form.

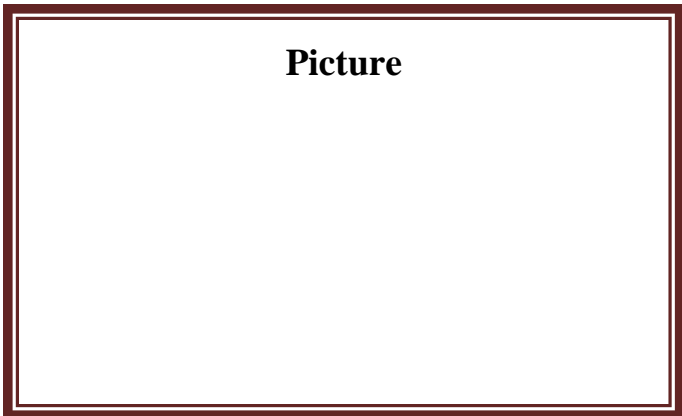
