## TOWN OF MAIDSTONE BYLAW NO. 04-2021

#### A BYLAW TO ESTABLISH UTILITY RATES

The Council of the Town of Maidstone in the Province of Saskatchewan enacts as follows:

#### PART I – DEFINITIONS

- 1. In this Bylaw:
- a) "Bi-monthly" shall refer to a two-month period;
- b) "CAO" or "Administrator" shall refer to the Chief Administrative Officer of the Town of Maidstone;
- c) "Council" shall refer to the Council of the Town of Maidstone;
- d) "Municipality" shall refer to the Town of Maidstone;
- e) "Property" shall mean a parcel of land on which a building or buildings (commercial or residential) may or may not be situated, whether such buildings are occupied or unoccupied;
- f) "Property Owner" shall mean those listed on the title of the property receiving those services governed by this Bylaw.

#### PART II - CONNECTIONS

- 2. All property owners desiring to be supplied with water by the Municipality shall make application to its officials. Each application shall be accompanied by a deposit in the sum of \$100.
- 3. All property owners desiring to be disconnected from the Municipality's water service shall make application to its officials. Upon successful application, deposits shall be refunded less any amounts owing to the Municipality.

### PART III - WATER CONSUMPTION RATES

- 4. The water charges to be paid by the property owner shall be as set out in Schedule "A" attached.
- 5. The flat fee minimum charge is payable whether or not any water has been consumed.
- 6. The Commercial Plus rate shall only be applied to those accounts which use water in the course of their business and whose average bi-monthly usage equals or exceeds 200 cubic meters.

### PART IV - SEWER RATES

- 7. The sewer charges to be paid by the property owner shall be as set out in Schedule "B" attached.
- 8. The flat fee minimum charge is payable whether or not any water has been consumed.

### PART V - OTHER FEES

- 9. Every property owner shall pay an infrastructure fee in accordance with Schedule "C" attached.
- 10. Every property owner within the Town of Maidstone shall pay a recycle fee in accordance with Schedule "C" attached.

### PART VI - INVOICING AND PENALTIES

- 11. Accounts shall cover a bi-monthly period, and shall be rendered on or before the first day of the month following such period.
- 12. Accounts shall be paid within 60 days from the date on which such accounts are rendered.
- 13. If an account is not paid within 60 days from the date on which such accounts are rendered, a 4% penalty per period will be charged to the account.
- 14. If an account is not paid within 90 days from the date on which such accounts are rendered, the water service may be shut off.
- 15. If a consumer's water supply is shut off for violation of the provisions of this Bylaw, the same shall not be turned on until all penalties, fees, rates, charges, and arrears, if any, have been paid.

### PART VII - REPEAL

16. Bylaw No. 2018-12 and Bylaw No. 2019-01 are hereby repealed.

### PART VIII - COMING INTO FORCE

17. The rates and charges contained in this Bylaw shall come into force on the day of approval by the Saskatchewan Municipal Board.
